# Background

The Youth Challenge Vanuatu (YCV) is a charitable non-government organisation that has been supporting youth leadership program in Vanuatu since 2001. YCV delivers services to up skill and empower young women and men in leadership, employment, education and small business development, Oxfam in Vanuatu and YCV have worked in partnership since 2007.

YCV have designed a one year project, known as Strengthen engagement and relationship with MOYDS, provincial government and Municipalities (Port Vila and Lugainville) which to empower young women and men to lead economic and social development in Vanuatu. This project is funded by Pacific People Advancing Change (PPAC), basically to assist YCV improving and expanding its services in youth employability, entrepreneurship and leadership, strengthen its organisational, academic and programme management, and develop income generating products, by establishing strong networking and partnership with selected partners.

# Purpose

The purpose of hiring a consultant is to assist YCV developing an MOU to clearly defines how YCV and its partners will work together and lays out each one's expectations and responsibilities. The goal is to achieve a mutual understanding of the partnership, especially to improve the relevance and effectiveness of its employability and leadership services to young women and men, and the efficiency, quality and sustainability of its operations.

## Objectives

The objectives and expected outcomes of the consultancy are as follows:

1. Strengthen engagement and relationship with the Ministry of Youth Development and Sport, National Youth Authority, Port Vila and Lugainville Municipalities and the Shefa and Sanma provincial government

#### Tasks – Priorities

The consultant will carry out the following tasks:

- I. Consultation meeting with selected partners
- II. Workshop and training with potential partners about the terms and conditions of working agreements
- III. Develop and signing of MOU with the selected partners
- IV. Prepare the final project report

#### Scope of work

Under the supervision of Youth Challenge Vanuatu, under this terms of reference, the consultant will be responsible for delivering the above priorities.

The duration of work contract will depend on the discussion between the partners, on agreed scope, outcomes and benefits.

### Methodology and processes

The consultant will be responsible for defining the methodology to be employed; however, it is expected that the consultancy will involve desktop review as well as extensive consultation with YCV stakeholders, and that the consultant will give priority to the voices and views of YCV directors and members.

### **Location of Consultancy**

The consultancy will take place in Port Vila and Lugainville

#### Deliverables

The outputs to be delivered are:

- 1. Revised and update YCV project plan (PPAC)
- 2. Deliver Partner training on the updated MOU
- 3. Finalist YCV and partners MOU

#### Schedule and milestones

The consultancy is expected to take place in December 2022 and possibility an extension to June 2023 at no extra cost and be completed by March 31<sup>st</sup> 2023 or April 30 2023. It is envisaged that the consultancy will require a maximum of 10 working days; however, consultants are encouraged to propose alternative timeframes in their expressions of interest if considered necessary.
