Program Overview

The Vanuatu Education Support Program Phase II (VESP II) is funded by the Australian Government's aid program and implemented in cooperation with the Government of Vanuatu. The program includes two components:

(a) Targeted support to MoET to implement the Vanuatu Education and Training Sector Strategy (VETSS); and

(b) Provision of the Australia Awards Vanuatu Scholarships and professional development and networking opportunities for alumni.

VESP II was designed to align with MoET's draft Corporate Plan (2018-20) and the NSDP. Specifically, VESP Phase II was designed to support MoET's contribution to NSDP Pillar 1 (quality education and social inclusion) and Pillar 3 (stable and equitable growth). In addition, VESP II aligned with MoET's Inclusive Education Policy and will support GoV's contribution to the Sustainable Development Goals (SDGs) – Goal 4 (ensure inclusive and quality education for all and lifelong learning) and Goal 10 (reduce inequality within and among countries).

Australia Awards in Vanuatu is also delivered under the same contract as VESP Phase II. The design facilitated management efficiencies and links between the two programs, including some shared operational costs.

Position Summary

The VESP Monitoring & Evaluation Officer will work under the guidance of VESP's Monitoring, Evaluation and Reporting Adviser. The M&E Officer will support the monitoring, evaluation and reporting of VESP's activities, contribute to the production of VESP's reports and the alignment of VESP's monitoring, evaluation, and reporting systems to MoET's.

The selected Officer will work closely with the teams implementing the VESP supported activities. These activities are aligned to the recently approved 2022-26 Corporate Plan. The Officer will support the implementing teams to monitor and evaluate the progress of these activities and their contribution towards outcomes.

Under the guidance of the MER Adviser, the Officer will be responsible for maintaining VESP's M&E data-base data-collection tools.

The Officer will assist efforts to develop the monitoring, evaluation and reporting capacity of MoET. The Ministry;s M&E team is located within the Policy and Planning Unit. The Officer will develop and maintain close relations of MoET's M&E team.

The Officer will be located in VESP's office, at the Ministry. It is expected that the Officer will be required to travel to the provinces occasionally.

- Maintain and update the VESP data management system.
- Support MoET to access VESP's supported activities' data.
- Support the VESP Communications Manager as required, in the preparation and presentation of information, data and associated infographics.
- Support MER Adviser to organize capacity development activities.
